# **TORPEDO AQUATIC PROGRAMMES AT SINGAPORE SPORTS HUB**



**'TORPEDO' IS HEREIN RECOGNIZED AS TORPEDO DIVE SCHOOL LLP, THE AQUATIC SERVICES REGISTERED AND INCORPORATED UNDER ACRA IN SINGAPORE**

Torpedo and / or their appointed representatives reserves the rights to amend/ make changes to the swimming programmes syllabus, structure or lesson duration. This includes cancelling or postponing of any swimming lessons/ events due to any unforeseen circumstances without giving prior notice.

## **REGISTRATION & TERMINATION**

1. New joiners are entitled to a free swim assessment before being assigned to a suitable class according to student's ability.
2. There is a one-time registration fee payment of **\$62.00 (non-refundable)**. A standard swim pack will be given after the term swim fee is paid.
3. In the event that any outstanding fees are not paid within 7 days from any payment reminder, the swimmer will be terminated from the swimming program.
4. For swimmer who is not continuing to the next term, please kindly inform our admin staff or coach in charge.
5. All participants are require to fill the Sportshub User Agreement Form before commencement of course.

## **PAYMENT OF FEES**

1. Each term starts in January, April, July, and October. Subjected to change based on venue and Torpedo's calendar.
2. Payment shall be made on a quarterly basis.
3. In the event when the swimming fees are **not paid by the start of the 1st lesson of the new term**, Torpedo reserves the right to give up the student's slot without any prior notice.
4. New joiner who joins mid-term; the 'per lesson' fee applies till the end of the quarter.
5. The swimming fees are exclusive of any test fees, certificate fees, printing fees and entrance fees. These fees shall be borne by the swimmer, if any.
6. All fees paid are strictly **non-refundable, non-transferable and cannot be prorated** under any circumstances.

## **REPLACEMENT LESSONS**

1. There shall be strictly **NO** replacement lessons for students who fail to turn up for the scheduled lessons.
2. In the event of bad weather conditions (i.e. lightning risk alert), land exercises will be conducted and the lesson will **NOT** be replaced.
3. In the event of bad weather conditions (i.e. haze/ air pollution) and land exercises are cancelled, the lesson will **NOT** be replaced.

You, the User:

- 5) agree that consumption of alcoholic beverages, smoking and bringing cans/glass containers inside the Venue is prohibited;
- 6) if required, must present your access card and photo identification upon entry and abide by the terms and conditions printed on the card;
