General

- Participants signed up for the lessons at their own risks.
- SPGG, Torpedo Swim School and / or and their appointed representatives reserves the rights to cancel or postpone the lessons due to any unforeseen circumstances without giving prior notices.
- Participants are not allowed to engage Torpedo Swim School's swimming instructors for private lessons outside of the clubhouse.
- SPGG reserves the rights to amend the terms and conditions from time to time where necessary and appropriate without prior notice.

Cancellation / Replacement of Classes

- Land drills will be conducted in sheltered areas if inclement weather does not permit the conduct of swimming lessons at the pool. Lessons will not be cancelled or postponed due to inclement weather.
- There shall be no replacement, proration or refund of classes except for cases where:
 - lesson is cancelled due to the absence of Instructors;
 - lesson is cancelled due to haze where 3-hr reading is at 151 and above;
 - Participant is absent for medical reasons, in such cases, participants must produce a Medical Certificate.

Payment of Fees

- Each new term starts every quarter of the year in January, April, July, and November. All Terms consists of 12 lessons.
- Unless classes are affected by public holiday or club events, fee will be prorated and indicated in the annual schedule uploaded in our website.
- Payment shall be made on a quarterly basis. Should a participant join mid-term; the 'per lesson' fee applies till the end of the quarter.
- Lesson fees must be made in full before the commencement of class via Torpedo Administration Staff/ Aquatic Manager.
- The Member/ Child's parent must have a valid SPGG Membership card to enjoy member's rates.**
- Fees must be paid one month in advance in full before the commencement of the term to reserve a place in the preferred class.
- All fees paid are strictly non-refundable and non-transferable.
- There is no entry fee to the swimming pool for the participant.
