1. The swim assessment is a free 20-30min session arranged to pre-assess your child before confirming a suitable class-slot.
2. *In the event of bad weather condition(s) (i.e. heavy downpour/ lightning risk), swimmers and parents may call the club half an hour before the actual lesson time to check the status of pool closure <Tel: 6586 1268 (WGCC Sports Reception)>
3. There will be NO lessons/ training on major public holidays and NO replacement or fee waiver/ pro-rata of lesson fee will be given for ALL cancellations due to inclement weather/ heavy downpour/ lightning risk/ air pollution like haze and etc.
4. Swimmers who are absent and has valid MCs may submit to Torpedo to arrange for class replacement.
5. Swimmers who are absent for the arranged test dates will have to sit for the next term's test as there will be no re-test.
6. "There shall be no pro-rata payments", students having their own agenda and not turning up for lesson/s on their chosen time slot/s according to the stipulated dates in the schedule will have their lesson/s forfeited.
7. All fee payment (Cash/ Cheque) shall be made payable to Torpedo Swim School LLP or via member's membership account.
8. *Please take note that there will be an additional 7% GST if Member/s prefers to make payment via the WGCC membership account.
9. All term fees paid are non-refundable and/or non-transferable.

10. All swimmers must serve 1 months' notice (with submission of termination form) for class termination 1 month before the commencement of a new term. Term fees will still be billed to your member's account monthly if no termination form is received by the school. Existing lessons paid for the term that is not attended will not be refundable/ transferable.
11. Class slots will not be reserved for swimmers who have terminated the program.

FAQ:

- **How do I sign up?**

Fill up the registration form at the counter, the coordinator from Torpedo Swim Team will contact you within 3 working days to arrange with you for a free 20 mins assessment to fit your child into a suitable lesson slot.

- **Will there be replacement or pro-ration of fees if lesson is cancelled due to inclement weather or air pollution?**

No, there will be no replacement classes or proration of fees if lesson or training is cancelled due to these weather or environmentally caused conditions. Replacement classes will be given to swimmers if no show of instructor/coach or if swimmers are sick with medical certification produced.

- **Are term fees paid, refundable or transferable?**

All term fees paid are non-refundable and/or non-transferable.

- **Why do I need to serve 1 months' notice for termination before the commencement of the following term?**

This allows the school to have ample time to process the termination form once it has been submitted to us. Failure to do so, members' account will be continued to be billed for the following term. By serving 1 months' notice, it also allows the school to effectively plan our class arrangements for the new term once your child's slot is released.

- **When will my child be assessed for test?**

For beginners and learn to swim programme will be every end of the term based on the Term schedule (16 weeks). A term schedule will be issued to all parents at the end of every term and will be uploaded at: www.torpedoswim.com.sg.

- **What happen if my child missed the stipulated term test date?**

Swimmers will be moved to the next level based on his/ her current swimming ability but certificate will not be given in such cases. Swimmers who miss the test can take the next Term test after 16 weeks based on their ability and level. They can opt for 2 certificates for current and the last level if they wish.

- **Test Fee?**

Test fee will be charged separately and will be collected after the Test on the test day itself.

- **How do I know what my child is learning?**
